The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 09.03.2017. The matter was placed in 285th Meeting of WRC held on December 19-21, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 20.02.2017, the institution vide letter dated 09.03.2017 has submitted scanned copy of 1+16 faculty members.

The institution is required to submit a list of 1+15 faculty in the NCTE format duly approved by the Registrar for the current academic year in original.

Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.4.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

- 7. AND, WHEREAS, the clarification letter was issued to the institution on 03.01.2018 and reply was submitted by the institution on 05.02.2018.
- 8. AND WHEREAS, the reply of show cause notice was submitted by the institution on 09.03.2017. The appeal Committee passed order dated 31.12.2018 remandback the case to the WRC, the matter was placed in 304<sup>th</sup> Meeting held on April 02 – 04, 2019 of WRC and the Committee decided that "...The original file of the Institution, Appeal order along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:-

On perusal of the reply dated 10/01/2019 of the institution it is observed that the institution has not submitted the following documents:

- The institution has not submitted a letter granting approval for the selection or appointment of faculty, issued by the affiliating body as per NCTE Regulations 2014
- The institution has not submitted original FDRs towards endowment fund and reserve fund as per regulations 2014.

Hence, the committee decided to withdrawal order No. WRC/APP2256/223/291/2018/197389—197394 dated 04/05/2018 stands."

- 11. AND, WHEREAS, the withdrawal order was issued to the institution on 11.04.2019. The institution filed W.P.(C) 4948/2019 & CM APPL.22011/2019-S in the Hon'ble High Court of Delhi. The Hon'ble High Court passed order dated 08.05.2019.
- 12. AND WHEREAS, the matter was placed in WRC its 307<sup>th</sup> Meeting held on May 30 31, 2019 and the Committee decided as under:-
- "...In view of the direction of the Hon'ble High Court of Delhi in W.P. (C) 4943/2019 & CM APPL 22011/2019-S order dated 08/05/2019 at point No. 11, the committee revisited the appeal order dated 31/12/2018 and the reply submitted by the institution dated 10/01/2019.
